Answering the Big Questions

Why are you changing your name?

We have outgrown our name. Our membership has expanded beyond the town of Dawson, and we need a name to encompass all our locations.

Has another financial institution bought the credit union?

No. We have not been sold or merged with another financial institution. We are the same credit union we have always been, just with a new name to reflect our growth.

What will happen to employees?

Employees will stay the same! The same faces you see today will still be part of the new Greater Community Credit Union.

When will the name change become official?

The name change will go into effect the weekend of July 1, 2023.

Will the values and community involvement of the credit union stay the same?

Yes, we will still strive to provide excellent service to our members and be actively involved in our communities. This change is about helping us reach as many potential members as possible.

Is there anything I need to do because of the name change?

There should be little to no impact on you as a member. Your account number(s) will remain the same, as will all your products and services. Your digital banking login and passwords will also stay the same. You can continue to use your DCCU checks until they run out. Greater Community Credit Union will be printed on new checks after you place a new order.

Will the routing number change?

No, the routing number will remain #291273549.

Can I continue to use my DCCU debit card or credit cards?

Yes, you can continue to use your DCCU debit/credit cards. Once they are up for renewal, you will receive new cards with Greater Community Credit Union printed on them. Make sure to activate your new cards right away!

Will the website address change?

Yes, we will launch our new website, www.greaterccu.com, on July 3. Please use this new address to access our website and to log in to your online banking on your desktop computer.

Will phone numbers and email addresses change?

Our phone numbers will remain the same at each location. Our email addresses will change to @greaterccu.com, and we will be adding the first letter of the last name of the team member. For example, sarah@dawsonco-opcu.com will become sarahf@greaterccu.com.

Will access to online banking or the mobile app change?

Your online banking login information and password will not change and can be used on our website or with the mobile app. You can log in to online banking on our new website starting July 3, 2023: greaterccu.com.

The mobile app will be updated on July 3 or within the following days. If you do not have automatic updates turned on for your phone, you may need to manually update the app when the update becomes available. You may see the old DCCU login until you update your app.

You will need to reauthenticate the devices you use to log in to online banking with a security code sent to the phone or email registered to your account.

Do I need to change my direct deposit or automatic payments?

All direct deposits, payroll deductions, automatic drafts and other ACH services are transmitted using the credit union's routing number and your account number. Since these numbers will not change, your payments will process without any change on your end.

How should I make payments on my loans with the credit union?

You can continue to make payments as you normally would. If you use a bill pay service to make your payments or pay by check, we recommend that you update the payee information to Greater Community Credit Union. If you have automatic payments set up, those payments will continue to process as normal.

Will the name change impact fees, loan rates and deposit rates?

None of these will be affected by the new name. Rates and fees do fluctuate, but they adjust in response to market conditions, not our name.
